
CERTIFICATE OF SUFFICIENCY AND ORDER

I, Danielle Zimmer, Board Clerk, pursuant to §9.10(3)(b) of the Wisconsin Statutes, certify that:

1. On December 6, 2018, a petition to recall School Board members: Sam Stewart and Danielle Zimmer, from the Flambeau School District, was offered for filing with the District pursuant to Article XIII, Section 12 of the Wisconsin Constitution and §9.10 of the Wisconsin Statutes.
2. A minimum of 398 signatures of qualified electors in the Flambeau School District, Rusk, Price, Taylor & Chippewa Counties, Wisconsin are required for the Board Clerk to file the petition and order a recall election pursuant to §9.10(3)(b) of the Wisconsin Statutes.
3. Based on a careful examination of the recall petition conducted by the Board Clerk, it was found that the petition to recall Board Member Sam Stewart contained 579 qualifying signatures of electors of Flambeau School District and, based on that finding, certified that the petition is sufficient to recall Board Member Sam Stewart and order a recall election.
4. Based on a careful examination of the recall petition conducted by the Board Clerk, it was found that the petition to recall Board Member Danielle Zimmer contained 569 qualifying signatures of electors of Flambeau School District and, based on that finding, certified that the petition is sufficient to recall Board Member Danielle Zimmer and order a recall election.
5. After review of the Challenges filed December 17th, 2018 by the incumbents, the Rebuttals filed December 19th, 2018 by the petitioners and the Replies filed December 21st, 2018 by the incumbents the Board Clerk, upon the recommendation provided by the Board Attorney, finds that the Statement of Reason on each petition is sufficient and a recall election is warranted.
6. The Board Clerk hereby files the petition pursuant to Wis. Stat. §9.10(3)(b), and a recall election for each board member is ordered this 7th day of January 2019.
7. The recall elections shall be held on Tuesday, February 19th, 2019. If a primary is necessary, the primary shall be held on that date and the recall elections shall be held on Tuesday, March 19th, 2019.

8. Persons seeking nomination for the recall election may file a Declaration of Candidacy and a Campaign Registration Statement no later than 5:00 p.m., on Tuesday, January 22nd, 2019, in the offices of the Flambeau School District, located at N4540 County Road I, Tony, Wisconsin. Wis. Stat. §§ 8.15(6)(dm), 9.10(3)(c).
9. Sam Stewart and Danielle Zimmer shall be candidates at the recall elections without nomination unless he or she resigns from their respective office no later than January 17th, 2019.
