**CHALLENGE**

I, Sam Stewart, Board President, pursuant to §9.10(4) of the Wisconsin Statutes, challenge that:

The reasons listed for both the "Statement of Reason for Recall" and the "Statement of Intent to Circulate Recall Petition" are reasons that are not related to my official responsibilities as Board President for the School District of Flambeau as laid out in §120.15 of the Wisconsin Statutes.

Reason #1 states: "I have lost confidence in the ability of Sam to govern the school district effectively." This is a personal belief statement with no explanation of any relation to my official responsibilities.


Reason #2 and the statement of reason states: "Sam is not making the best decisions in the interest of the students, staff & taxpayers." A personal statement and assumption of the petitioner with no correlation to my official duties and no support of that assumption is offered.

Reason #3 states: "Sam is interfering with Administration not allowing them to do their jobs effectively." Another opinion with no basis provided.

Reason #4 states: "Sam poses as a negative representative for the school district." A fourth opinion, which again is not related to my responsibilities as a board member.

Each reason is an opinion of the petitioner with no foundation. Each reason is an attempt to tarnish a reputation not a reason or basis for a recall. It clearly states in the Recall Manual and on the Recall Petition header that the reason for recall must be related to the official responsibilities of the officeholder. While the petitioner is entitled to a personal opinion of me that is not a basis for a recall. Each of the reasons provided assert a personal attack on my character. Each reason fails to provide any basis for a recall related to my official responsibilities as not only Board President but as a Board Member.


